



SCHOLARSHIP APPLICATION

Applicant must:

1. Be a resident of Cass County, MO
 2. Be 18 years or older
 3. Attach the following items:
 - Most recent Federal Income Tax Return
 - Last 2 paystubs for each job held in household, or letter from employer stating income
 - Letter from social worker indicating the amount of benefits you are receiving
 - Valid photo ID
 - Family Income Worksheet
 - Application

- Financial Assistance is based upon income and household size in accordance with the School Lunch Program guidelines.
Scholarships are granted at the discretion of the Parks & Rec Department
 - Each scholarship recipient household is given the choice of one family membership or 2 activities per child per year for the household.
Additional activities/membership may be allowed at the discretion of the department.
 - The Scholarship Committee will process all requests within 3-4 weeks of receiving the application and all supporting documentation.
 - Notification of a decision will be made by phone or mail.
If awarded, the recipient will be contacted regarding the qualifying amount and the co-payment needed.
If denied, the individual will be notified of the reason(s) for denial. The individual has the option to file an appeal with the Director of Parks and Recreation.
 - Any membership or activity received with the aid of financial assistance is valid only for the qualified individual and/or their family members and cannot be transferred to anyone else.
 - Each recipient is required to notify the Department if they withdraw from an activity or membership. Failure to notify the Department in a timely manner may result in the denial of future use of the program.
